HAVE YOUR SAY: MEMORIAL PARK REDEVELOPMENT DRAFT CONCEPT PLAN

Your feedback will help guide the development and long-term management of Memorial Park. The aim is to create vibrant and welcoming place for residents and visitors to meet, rest and play; while supporting our local businesses to be the very best they can be. The project will be the centrepiece of Pingelly's economic and social recovery following COVID-19 by:

- Creating local jobs during and after construction
- Sourcing materials locally to build and maintain the space
- Encouraging new spending opportunities in our CBD by developing an attractive stopover for pass-through traffic
- Providing a dynamic space for local families, children and young people to remain socially engaged and physically active
- Supporting community groups to activate the town with a purpose-built space for events
- Improving access and amenity for senior residents using the park

MAY COUNCIL MEETING HIGHLIGHTS

Solar Panels Council endorsed provision in the 2020/21 budget to install solar panels to the roof of the Shire building, which will lead to a significant saving in electricity bills for future years.

National Redress Scheme Council endorsed the Shire of Pingelly's participation in the National Redress Scheme as a State Government institution and included as part of the State Government's declaration.

Road Asset Management Plan 2020 – 2039 Council adopted the Road Asset Management Plan 2020 – 2039.

Pingelly Caravan Park Master Plan Council approved a master plan be developed for the Shire of Pingelly Caravan Park.

Councillor Training and Development Policy Council adopted an updated version of this Policy following legislative changes.

Pingelly Swimming Pool Council approved a 2019/20 budget amendment of \$30,000, being for repairs to the expansion joint and repainting of the pool bowl, to be funded in full from the Swimming Pool Reserve Account.

Grant Guru Council endorsed \$775 to be allocated in the draft 2020-21 Budget for the purpose of joining the Grant Guru program.

Disability Access and Inclusion Plan 2020-25 Council adopted the Plan following it being endorsed by Department of Communities.

Pingelly Waste Management Facility Council authorised the reduction in the level of service from four days per week to three days per week as at 1 July 2020.

Bush Fire Control Order Council endorsed the Order for the 2020/21 season, the appointment of Chief Fire Control Officer, Deputy Chief Bush Fire Officer and Captain of the district of the Shire of Pingelly.
