## HALL STREET AND PRINCESS STREET MODIFICATION

At the Ordinary Council Meeting in August, Council considered the feedback received during the public comment period and has endorsed the following:

### Hall Street

- Retain existing parallel caravan parking on the north side of Hall Street.
- Modify Hall Street to become a one-way street, eastbound (west to east) from Parade Street to Princess Street

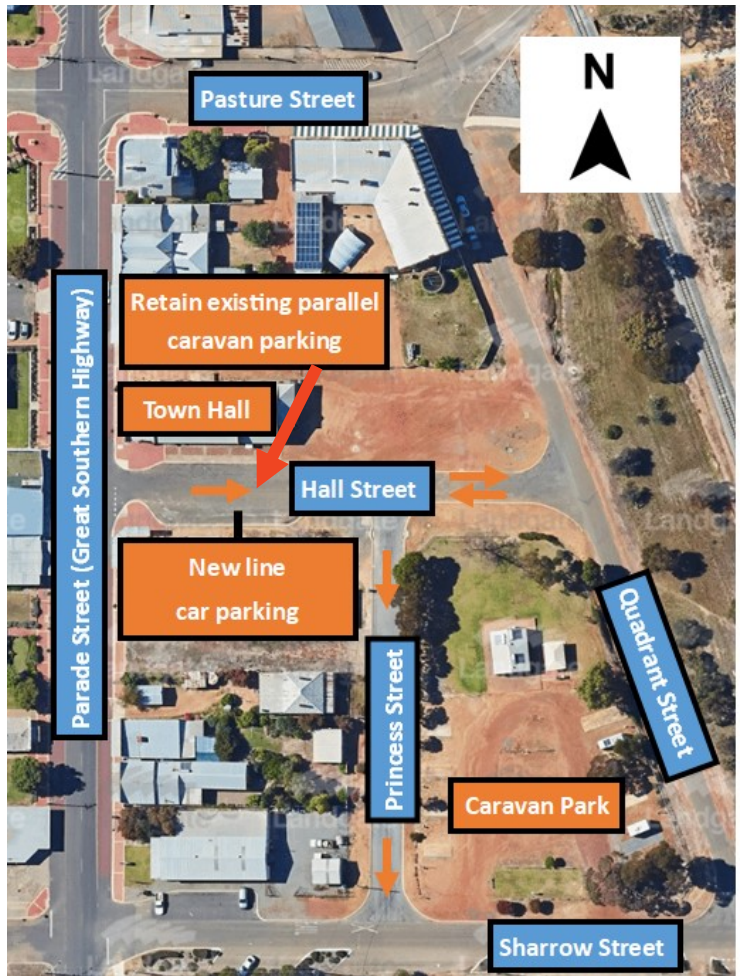
### Princess Street

- Princess Street to become a one-way street, southbound (north to south) from Hall Street to Sharrow Street.

These modifications will improve access to the Town Hall Project for residents and visitors approaching from Parade Street (Great Southern Highway).

Following recent success with the Federal Government's Driver Reviver Point Driver Reviver Upgrade Grant, and the WA Government's Small Grants Program to progress the first stage of the Town Hall Future Use Project encompassing the tourism function, the Working Group is continuing to provide input into the detailed design elements.

## PINGELLY YOUTH STRATEGY 2021-25 ENDORSED

The Shire of Pingelly, in conjunction with the Pingelly Youth Network, conducted the It Starts With 'You'th consultation series to understand the needs and aspirations of local young people.

Following the facilitation of surveys, pop-up booths and workshops, the Pingelly Youth Network collated the data to inform strategies and actions to implement a youth-led vision for Pingelly within organisational and community capacity.

A further opportunity for the broader community to provide input into the Draft Strategy, before the final version as adopted at the Ordinary Council Meeting in August. The Pingelly Youth Network are now set with a blueprint to work collaboratively to develop projects and initiatives for young people.



## AUGUST COUNCIL MEETING HIGHLIGHTS

### Draft Policy - Standards for Chief Executive Recruitment

Council adopted a policy around the standards for the future Recruitment, Performance Review and Termination of Chief Executive Officers in compliance with recent legislation changes. A copy of this policy can be found on the Shire's website.

### Certificate of Compliance – CEO Recruitment Process

Council certified that the recruitment and employment of CEO Mr Andrew Dover was undertaken in accordance with the standards for the Recruitment, Performance and Termination of Chief Executive Officers policy. A copy of this certification was sent to the Department of Local Government, Sport and Cultural Industries

### Management Order – 13 Balfour Street

Council approved a request to have a management order for 13 (lot 807 Reserve 23053) Balfour Street Pingelly issued to the Shire of Pingelly. This reserve will be designated "Community Purposes".

### Old Courthouse Expressions of Interest

Council extended the period for submissions in relation to seeking a tenant for the Old Courthouse building to activate Memorial Park.

### REED Lease

Council approved a 1 year peppercorn lease with a 1 year additional option of 22 Queen Street Pingelly to REED (Regional Early Education and Development) for the provision of Childcare services

### Pingelly Youth Strategy 2021-25

Council adopted the Pingelly Youth Strategy 2021-25. A copy of this plan is available on the Shire's website

### Town Hall Project – Hall Street and Princess Street Consultation

Council endorsed the proposed modification to Hall Street and Princess Street.

### Proposed Second Shed

Council granted permission for a second shed to be constructed at Lot 390 (60) Pitt Street Pingelly.

## CALL FOR COUNCILLOR NOMINATIONS

A Local Government Election to be held on Saturday, 16 October 2021 to fill vacancies at the Shire of Pingelly.

### The Role of a Councillor

The role of a Councillor is to provide leadership and guidance to the community; facilitate communication between the community and the Shire; determine and review policy; plan for the future of the area and consider the annual budget in consultation with fellow Councillors.

Councillors do not have any authority to act or make decisions as individuals. Decisions are made through a formal meeting process.

### Nomination Time and Place

Candidates are required to lodge with the *Returning Officer*:

- a completed nomination in the prescribed form, signed and witnessed. This form is available from the Shire of Pingelly.
- a single A4 page profile containing not more than 800 characters, containing biographical information about the proposed candidate and statements of the candidate's policies and beliefs.
- a nomination deposit of \$80 (cash, cheque, bank draft or postal order, or other means subject to Returning Officer approval).
- a recent passport-sized photograph (optional).

To nominate, every individual must complete induction for prospective candidate's course, available via the Department of Local Government, Sport and Cultural Industries website at [www.dlgsc.wa.gov.au](http://www.dlgsc.wa.gov.au)

Where an agent lodges a nomination on a candidate's behalf, it must be in the prescribed form with a written authorisation signed by the candidate.

The documents may be hand delivered, posted, faxed, or sent by electronic means to the Returning Officer and must be received by close of nominations.
