WORKS REPORT

MAINTENANCE GRADING

The Shire's Works Crew have continued to work hard and make progress maintenance grading. In some locations, additional gravel has been added to identified problematic spots ahead to progressively improve the road standard. Although the weather has been patchy, work has continued with only a few days lost to the wettest periods. On the plus side, the wet weather has left enough moisture in the gravel so that the heavy winter grade produces the best results and that the gravel road network is ready for the upcoming harvest.

DRAINAGE WORKS

The Works Crew are focusing on culvert maintenance and have cleaned several smaller culverts, drainage pipes and drainage channels throughout the Shire. Culverts, drainage pipes and channels ensure that water does not impact the road and so drainage works completed now will reduce future damage. The Crew have also replaced culverts on Marshall, Yenellin and Dwarlaking Roads.

PARKS & GARDENS

The Town Crew have completed many and diverse tasks over the period including footpath and streetscape beautification, slashing, mowing and spraying.

The footpath and streetscape beautification has been wonderful initiative and the Team have done a magnificent job on Raglan Street, Quadrant Street opposite the Exchange in putting in stunning native shrubs, trees and plants and a covering of mulch to give the final look a real earthy and Country Town feel about them. The maintenance and upkeep will be crucial, but managed well these gardens will only improve the outlook and look as the vegetation grows and matures. We believe this to be the footprint for the remainder of the Town in the coming years.

TOWN PLANNING SCHEME

The Shire is currently undertaking a 42 day community consultation for proposed amendments to its local Town Planning Scheme. Your feedback enables the Shire to gather valuable insights and perspectives and helps to ensure that planning decisions reflect the needs and aspirations of the people who will be most affected by them.

A comprehensive review of the Town Planning Scheme has not been completed since the Scheme's gazettal in 2008. The Town Planning Scheme is formed by two documents - the Scheme Text and the Scheme Maps. Both of these documents are proposed to be amended and are available on the Shire's website and are available to view at the Shire Offices. The purpose of the proposed changes is to modernise and simplify both the text and maps.
