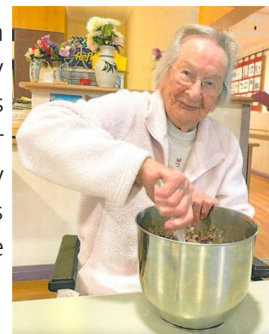


## ELLIE PARSONS TURNS 103
