## HERITAGE SURVEY, LIST & POLICY

The Local Heritage Survey and Heritage List have been officially adopted by Council following exhaustive consultation. This marks an important step in preserving our cultural and historical assets. This comprehensive review aligns these documents with the updated legislation, updates information on existing heritage places within the documents and adds new heritage places that have not been previously included. Overall, these documents are more comprehensive and user friendly.

The Heritage Survey is the official record of the places of historical importance within Pingelly, including the reasons why these places are important. The most significant places on this Survey have been identified for protection on the Heritage List. A Local Planning Policy (LPP) has been drafted to ensure that the of being on the Heritage List protection is not overly onerous and the requirements are clear. This draft LPP is currently available for comment.
