RESTRICTED BURNING PERIOD

During the restricted burning period from March 1st to March 29th, permits for burning may be issued for a maximum duration of one week. The hours during which burning is allowed may be specified as a condition of the permit. Additionally, it is required that at least three people be present for the entire duration of the burn. Before lighting the fire, the permit holder must notify the staff at the Shire Office by phone at 9887 1066. This is to prevent false emergencies and ensure proper oversight of the burning activities. It's important to note that the restricted or prohibited burning times may be adjusted based on seasonal conditions. This means that the period may be shortened, extended, or suspended as necessary.



LOCAL CAT LAW ADOPTED

The Cat Law was adopted by the Council last Wednesday. The purpose of this law is to protect our native wildlife. This legislation imposes a crucial restriction, prohibiting cats from entering all reserves within the Shire to limit their impact on the local ecosystem. To most effectively comply with this requirement, it is recommended that cats are confined within your property. It is now also an offence to interfere with a cat trap.

Under the law, residents are permitted to maintain a maximum of two cats on their properties. These requirements are in addition to the existing requirements which requires all cats to be registered and microchipped.
