5. RESPONSE TO PREVIOUS PUBLIC QUESTIONS TAKEN ON NOTICE

President welcomes Ms Leona Ebsworth to the podium.

Q1: I would like to know about the possibility of heating the community pool.

CEO Response: The strategic plan includes investigating a hydrotherapy pool and developing an asset replacement plan for the swimming pool. Heating was raised during discussions; quotes are being obtained for solar heating. Not included in this year's budget but will be part of the overall pool plan.

Q2: Is solar the only option?

CEO Response: Solar is the most efficient and cost-effective option, requiring only pump costs. Other heating options exist but are more expensive

Q3: I wish to address the current state of footpaths within our town, and am asking what can be done to improve them?

EMW Response: Footpaths compete with road maintenance for funding, both are in poor condition. Renewal programs are costly but prioritised by need (e.g., Park Street near the school).

CEO Response: Funding depends on grants, with applications submitted for the Active

Transport Grant. No specific footpaths decided yet. Success of application is uncertain.

Q4: So, this is dependent on money and nothing feasible within the short future?

CEO Response: Correct.

Q5: The trucks coming down Park Street - there is a sign that states "Please Turn". Why is this not policed?

EMW Response: The Secondary Freight Network plan will redirect trucks to Balfour Street, bypassing Park and Paragon Streets. Balfour Street development is underway to support this change, ensuring trucks avoid the school area.

Q6: Why do we get charged for two bins when all our rubbish goes to the same place?

CEO Response: Recycling goes to the plant unless contaminated. Contamination is monitored via cameras, and contaminated loads are redirected to the tip.

- Cr Hotham suggests the Shire advertise in the Pingelly Times 3-4 times a year to remind the community about what is and isn't recyclable.
- Cr Singh proposes adding stickers to recycling bins with this information.
- CEO acknowledges both suggestions and notes that recycling plants vary in what they accept, and each Shire adjusts its recycling guidelines accordingly.

The shire President thanks Leona for her time and for her questions. Leona takes a seat.

Summary

Council is requested to endorse the Pingelly Signature Event Working Group Terms of Reference as attached and send invitation to the inaugural members of the Working Group.

Background

Pingelly has been searching for a defining major event which will put the town 'on the map'. Over the years there has been the Tulip Festival, Country Collective, and most recently the Shire has organised the FAM Festival. For this Festival to grow and be sustainable, this event should be organised by a team of invested individuals/groups who work together to make this event the best it can be. This is similar to various other organisational committees e.g. Kulin Bush Races, Wandering Camp Out, Cuby Groove Fest and the traditional agricultural shows.

Comment

It is intended that the Working Group membership is comprised of members who will actively participate in organising a large signature event, including mobilising the resources of their organisation (e.g. volunteers, contacts etc.) with the agreement of the respective group.

It is recommended that invitations be sent to the following to be the initial members of the Working Group:

- Shire of Pingelly (Councillor and Staff)
- Pingelly Tourism Group
- Pingelly Recreation and Cultural Centre

Terms of Reference - Pingelly Signature Event Working Group

1. Purpose

Promote Pingelly and to support local businesses by creating and running one main annual event for Pingelly which will attract at least 1,000 people each year.

2. Decision Making

- 2.1. The Working Group is a collective consensus-building body, which relies on its members carrying out its resolutions in their own capacity e.g. as a community member, chair of a body or employee of an organisation.
- 2.2. No organisation, including the Shire of Pingelly, have delegated their authority to this Working Group.

3. Membership

- 3.1. The Working Group membership will be primarily skill and action based. Members are expected to be actively involved in carrying out any agreed actions. This is a condition of membership.
- 3.2. The Shire of Pingelly will invite initial members to become part of the Working Group.
- 3.3. Membership will not exceed 10 members.
- 3.4. Invitations to become a member will be sent as and when agreed by the Working Group, provided the potential member bring both a level of expertise/experience and a willingness and ability to work.
- 3.5. Any members that do not carry out their agreed actions or do not attend the Working Group meetings for a period of 3 months are no longer regarded as members of the Group. This does not apply if notice has been provided of extended leave.

4. Chairperson

The Shire President will chair the meetings, with a Deputy Chairperson elected from the membership of the Working Group.

5. Actions

The Shire of Pingelly will record attendance and provide a list of agreed actions and the members responsible for them, following each meeting. It is the responsibility of the individual member to carry out these actions.

6. Meetings

The schedule of meetings will be agreed by the Working Group and are expected to be approximately one meeting per month.

7. Variations

Any variations to these Terms of Reference are to be endorsed by the Working Group.

- (2) Each statement of financial activity is to be accompanied by documents containing -

- (a) An explanation of the composition of the net current assets of the month to which the statement relates, less committed assets and restricted assets;
- (b) An explanation of each of the material variances referred to in sub regulation (1) (d); and
- (c) Such other supporting information as is considered relevant by the local government.
- (3) The information in a statement of financial activity may be shown -
 - (a) According to nature and type classification;
 - (b) By program; or
 - (c) By business unit.
- (4) A statement of financial activity, and the accompanying documents referred to in sub regulation (2), is to be -
 - (a) Presented to the council -
 - (i) At the next ordinary meeting of the council following the end of the month to which the statement relates; or
 - (ii) if the statement is not prepared in time to present it to the meeting referred to in subparagraph (i), to the next ordinary meeting of the council after that meeting; and
 - (b) Recorded in the minutes of the meeting at which it is presented.
- (5) Each financial year, a local government is to adopt a percentage or value, calculated in accordance with AAS 5, to be used in statements of financial activity for reporting material variances.

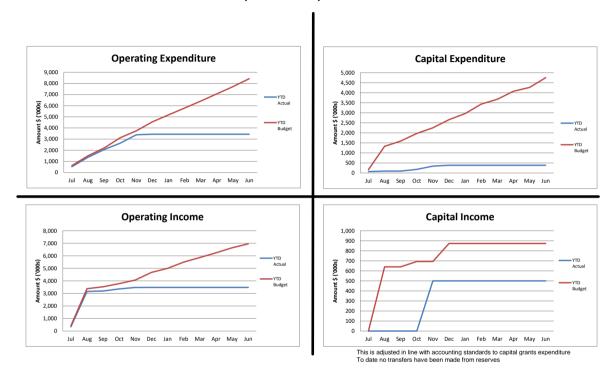

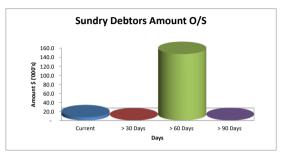

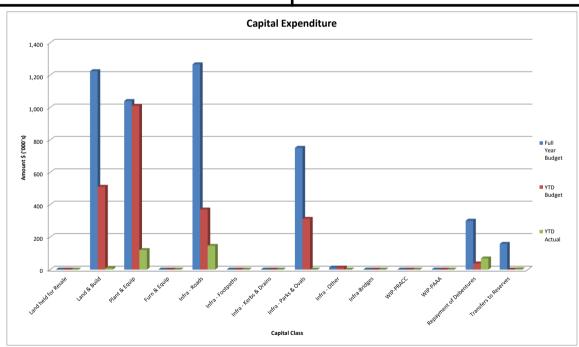
Income and Expenditure Graphs to 30 November 2024
