14.1 Council Meetings and Corporate Discussion

Summary

To adopt an amended and streamlined schedule of Corporate Discussions and Ordinary Council meetings.

- d) Key issues raised by Chief Executive Officer
- e) Key issues raised by Councillors

- a) Lunch 12.30pm
- b) Council meeting 2pm commencement (no change from present schedule) Normal meeting procedures but note that in the event more detailed discussion is required on any item Standing Orders may be suspended by resolution of the Council. Councillors will be encouraged to submit any questions on agenda items in advance to ensure that answers are available at the meeting.
- c) Following the Council meeting Councillors and the Chief Executive Officer may raise any matter that cannot wait until the next Corporate Discussion".
